A nation torn apart by war. 300,000 Americans dead. Investigations into Watergate have just begun.

Elizabeth Holtzman wins a congressional seat and comes to Washington to end the Vietnam War.

Utapo Air Force Base, Thailand. Four US pilots face court martial for refusing to fly bombing raids into Cambodia.


"I'm asking for a stay of execution for all those innocent people who are about to wake up in the morning, no idea that an American bomb is about to be dropped on their heads!"

When Burt lands the case of the four pilots, he knows this could be his chance to make history and have the Pentagon ordered to cease all military action.

But in order to win, Burt will have to find a way to convince the Supreme Court to interfere with Presidential authority and bring an end to a conflict that has ripped a nation apart.



An American icon. The first African American Justice of the Supreme Court and the famed civil rights attorney who ended school segregation in the case of *Brown v. Board of Education*.

With the Supreme Court out of session, Burt and Liz take their efforts to stop the bombing before Marshall, fully expecting the civil rights hero to rule in their favor.

Marshall is forced to make a painful decision, one that will turn his clerks and allies against him and test the integrity of the Court for years to come.

"They tried to impeach me. What is this country if one man, one very corrupt man, thinks he has absolute power?"


Cantankerous, a rebel, known as "Wild Bill' by his peers.

A leading Liberal voice on the Supreme Court for forty years and outspoken critic of American involvement in Vietnam. In 1970, the Nixon administration attempted to impeach him for trying to use the Court to end the years long conflict.

Burt and Liz ultimately take their case to Douglas, who grants them an impromptu hearing from his home in Yakima, Washington, setting the stage for a final legal battle and one last chance to make history.

# freedom deal and the illegal bombing of cambodia

"I want to hit everything, I want them to use the big planes...let's start giving them a little shock."


Operation Freedom Deal (1970–1973): a secret bombing campaign on the neutral country of Cambodia. The action was led by Nixon, and executed without Congressional approval.

500,000 tons of bombs dropped. Up to 150,000 innocent civilians killed. Nearly 20 percent of the land destroyed.

Nixon believed in his "Madman Theory," a plan to frighten the North Vietnamese into thinking he was crazy enough to do anything to win the war.

"He can't be restrained when he's angry—and he has his hand on the nuclear button."





# rule 509/watergate

"I didn't know it at the time, but this one little act took down a Presidency."

Rule 509, a provision buried in a bill before Congress. If passed, it would have allowed Nixon to withhold evidence from an investigation, claiming Presidential privilege over state secrets.

Liz Holtzman is assigned to sit on the House Judiciary committee, which is just starting to investigate the break-ins at the Watergate hotel. She discovers the administration trying to sneak through a Presidential "secrets act" in the form of Rule 509.

Liz goes before Congress and strikes Rule 509 down in March of '73. She had no way of knowing that her actions would soon compel Nixon to turn over his Oval Office recordings and force his resignation.
